

- Promotion (events, CAF movie (cartoon), publications, posters, e-Newsletters, ...)






- 2016 -2022 (EU/ESF funded)

 - Annual cyclic model (motivation, invitation, kick off meeting, "Helpdesk/Consulting", PEF, analysis, concluding meeting)








Annual Cycling Model



Finance (EU/ESF)

- Scope: 363.500 €, (app.51.000/year):
 - 1. work-costs
 - 2. conferences (1/per year)
 - 3. CAF PEF Actors
 - 4. information, promotion...









CAF in Slovenia 2002-2019

Period 2002 - 2016: 59 CAF users

Period 2017 - 2018:

- Top-down approach
- "CAF beginners": 38 self-assessments (for the 1st time) ministries, municipalities, public institutes….
- "CAF users": 55 self-assessments (repeating) PA organisations
- 2 Pilot projects for CAF PEF: 20 applicants
- CAF Training: 470 civil servants
- CAF PEF Actors Training: 38 civil servants
- Events: QR meetings, consultations (Applicants, FA), EOQ Congress, (annual) Quality conference, Award ceremonies









CAF 2019

- "CAF beginners": 12 self-assessments (Gov.offices, agencies, municipalities, libraries…)
- "CAF users": 15 self-assessments
- CAF Training: 150 civil servants
- 1st regular CAF PEF: 5 Applicants, 14 Feedback Actors
- Annual Quality Conference in November
- Award Ceremony in January 2020
